



## **You Call The Game Contest Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

### **HOW TO ENTER**

The contest is open to all eligible residents September 3, 2010 through October 31, 2010.

To participate in the contest, submit a 2 minute MP3 ONLY file to [info@sfmsports.net](mailto:info@sfmsports.net). When submitting the entry, include your first name and last name, complete address, city, state, zip code, home telephone number and a valid email address in the online entry form. Additional information may be required. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.

The Network is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. If entries are accepted via mail or at other locations, "The Network is not responsible for lost, stolen, mangled, misdelivered, postage due, illegible, incomplete or late entries. If telephone entries are accepted for a specific contest "The Network is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

### **ELIGIBILITY RESTRICTIONS**

The contest is open to all persons who 16 years of age or older, unless the specific contest rules stipulate a different minimum age to enter. Entrants must live in Maryland, Delaware, Virginia, West Virginia, District of Columbia and/or Pennsylvania. Employees of SFMSports.Net, Sound Foundations Media, affiliate stations, their licensees, corporate parents, subsidiaries, and affiliates, this network's advertising agencies, participating sponsors/promotional partners, other radio stations in the the Baltimore, MD; Washington, DC or Salisbury-Ocean City, MD metropolitan areas and the members of their immediate families and households are ineligible to participate or win.

You and members of the same household/address may win only one contest per calendar month.

Contestants are required to provide truthful information and the Network will reject and delete any entry that it discovers to be false or fraudulent. The Network will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

All prizes or prize certificates will be mailed to the contestant winner with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Network is not responsible for the safe arrival of a prize or prize certificate.

There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

## **WINNER SELECTION AND NOTIFICATION**

Decisions of Network management with respect to the contest are final.

SFMSports.Net management will select one weekly entry each Thursday at 6pm, EST. The Grand Prize winner will be selected and notified on Monday, November 1 at 12pm, EST.

Winner(s) need not listen to win, unless specifically mentioned in the contest rules.

“Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within ten (10) days of notification attempt or prize will be forfeited and an alternate winner may be chosen.

## **CONDITIONS**
